3. Avebury WHS Transport Strategy	
Transport Exhibition and public feedback (AW)	
AW Transport Group – community and PC working together on transport issues.	
3 <sup>rd</sup> March held an exhibition for public on issues that are important, a 'rain check' at	
Red Lion. A series of 'boards' each focusing on a specific problem, what are we	
doing, what solutions might there be? Feedback was gathered on post-it notes. The	
event was well received, 50+ responses. Results written up and analysed. Identified	



a need to collect more information – work in progress. Outcomes to be discussed at annual PC village meeting next week and going to present the exhibition to neighbouring PC's.

Commentary on Avenue/A4 and footpaths highest feedback. Wiltshire Council Highways have confirmed that any A4 traffic slowing/narrowing scheme cannot go forward without B4003 being closed as it would not have safe sight lines for turning off the A4. Satnav issue – Parish Council is writing to the companies to see if changes can be made.

JD Is there a one-way only option? Too much signage and less benefits.

CS Would closure in one direction help protect the monument? Is there an emergency order that could be put in place?

SS a temporary measure is being explored with Highways to backfill edges. GS wants to see speed limited from Fyfield all the way to Beckhampton. The key driver for closure of the B4003 must be protection of the monument there is unrecoverable damage.

JD still lots of work to do with the wider community to demonstrate the impacts HO need to sell the 'vision' and aspiration for the future, what it might look like. SS there was an illustration by Alice Macaire in the exhibition demonstrating this. RB need 30 miles an hour all the way from Avebury to Beckhampton roundabout. JD why didn't Atkins include the section to Fyfield?

SS suggested it could be extended if there is wider local support.

SS please can the committee all act as advocates for the WHS and the Management Plan and work to explain the impacts of the traffic and roads for which we have evidence.

AW the outcomes/recommendations of the transport group will be going on the Avebury PC website.

JT the aerial picture is a powerful showing how the B4003 conflicts with the protection of the Avenue

RF happy to provide any further info, images etc to help get the message across AW be useful to have members of this Committee to come along and talk and explain.

CS will put the issue to ASARGH so they can provide a statement. Suggested an experimental closure for 3 months

JD action with Steve Hinds to see if 'something can be done' now. Temporary or emergency closure, weight limit.

SS added that a weight limit was discounted by the working group including a police representative as unenforceable. In addition, weight is not the main issue.

AW Atkins stopped work at West Kennet until B4003 decision made but have started took at traffic calming work at Beckhampton roundabout.

HM explained a small sub group of the PC was developing a Principles and Guidelines Document to enable a coordinated and cohesive replacement/revision of signage across the WHS.

### **Footpaths**

CS expressed concern re road verges being used as footpaths (note this happened when the closure of the henge and other footpaths was in place)

### 4. A303 Scheme Consultation

Extraordinary meeting held notes circulated.

SS will respond as WHSCU Partnership Manager giving advice based on the Management Plan. Look at how the scheme aligns with the aims and policies and where mitigation will be required. Welcomes change in preferred route but outstanding areas of concern.

JT - SS gave an outstanding presentation to UNESCO at their visit and was very clear on nature of one World Heritage Site and its OUV.

CS concern that if planning permission is given it could put the WH status 'at risk' and it might even be withdrawn if the scheme were to go ahead (note this would also impact on Avebury). Concern that tunnel cuts through archaeology on western side of the WHS which is important in relationship to activity pre-Stonehenge monument. Group of barrows near western portal have Beaker burials. Links to the wider landscape will be severely impinged.

SS circulated statement from Historic England

HO AONB will be doing a response

SS would have liked to have the results of the Historic Impact Assessment to be able to comment more accurately

SS – neither the Stonehenge nor Avebury Committee can give a unified response due to the nature of the Committee – made up of partner organisations with different views. Note this is not dissimilar to other WHS Committees at other WHSs. JT – National Trust put out joint statement with EH and HE which is broadly supportive

National Trust broadly welcomes the proposals by Highways England for the A303 in the SH half of the WHS that are currently being consulted on subject to: the incorporation of a 200m grass-covered canopy at the western end, steep sided cuttings and a sensitively-located and designed green bridge to diminish the impact of traffic and the road in the west. In addition, the NT seeks the withdrawal of the proposal for a new linking Byway Open to All Traffic between Byways 11 & 12. CS talked to UNESCO on behalf of ASARGH and commentary is based on impact to archaeology.

MPK Wiltshire Council response will need to get Cabinet approval, looking at how the scheme aligns with the WC Corporate Plan. Like others requires more information in certain areas to comment but in general supportive.

HO fundamental principle of large infrastructure project in WHS will cause irrevocable damage.

SP Natural England will be putting formal response forwards but concern about lack of detail re wildlife at this stage.

# National Trust (JT)

**Breaking Ground Exhibition & Leaflet** To mark the 100-year anniversary of some women gaining the right to vote in Britain, this year at Avebury in collaboration with Trowel Blazers, the NT are bringing to light the contributions made by female archaeologists in the twentieth century through an exhibition in the Barn Gallery of the AKM & an accompanying leaflet.

**AKM** Undertaken a refresh of the Barn Gallery of the AKM.

**World Heritage Day 18 April** AKM free entry for the day. Huge thanks to Helen Miah and team for work clearing rubbish around Windmill Hill.

**Human Henge** Our work with Human Henge continued at Avebury. Briony Clifton presented (together with Martin Alfrey of EHT) on Human Henge, and the NT and Avebury at the recent Conference at Bournemouth University.

**Virtual Avebury** NT partnering with Bournemouth University, Daden and Sat Symph in an AHRC /EPSRC funded research project to develop and test a Virtual version of Avebury

**Living with Monuments** the Living with Monuments Project team (AHRC funded) have this week returned to the foot of Avebury Down to complete the excavations they started last summer



**Cobblestones Second-hand Bookshop** Now opened. Volunteer-led and run. **Closures** As a result of prolonged mild wet weather this winter and spring the NT have put in place temporary closures to parts of the henge & the WK Avenue to prevent damage to archaeology. The condition of the monuments has been regularly monitored throughout and the WK Avenue has now reopened.

# Wiltshire Council (RF)
